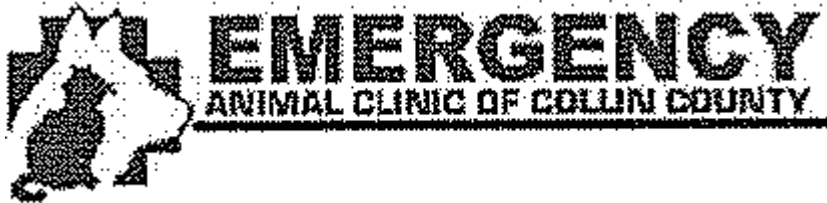

**Raffle:** A raffle table will be setup and tickets will be sold during the show. Proceeds will benefit growing Teacup Agility in Texas.

**Food:** We will NOT have a food vendor on site. There are a few fast food places not too far away.

## NOTICE TO EXHIBITORS

1. The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and are able to perform all obstacles safely.
2. All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area. It is expressly understood that exhibitors alone are responsible for the actions of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive activity, may, at the discretion of the Trial Committee, be asked to leave the Trial Site.
3. Bitches in season are not permitted in the trial. Refunds will be given to bitches in season, up to when the trial begins.
4. Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
5. Exhibitors are responsible for being at the ring gate when it is their turn to run.
6. Exhibitors may wear shirts or insignia of their training group if they wish.
7. At the handler's option, the dog may wear a flat (buckle or quick release) collar without tags or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
8. Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in being excused from the ring.
9. Please remember it is your responsibility to pickup after your dogs at the trial site as well as the hotels. Some bags will be provided at the trial site at various locations as well as designated disposal areas.

**Obstacle Familiarization**— Obstacle familiarization will be held Saturday and Sunday mornings 30 minutes prior to judging for dogs and handlers who have not previously seen TDAA equipment.

**Warm—Ups:** A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

**TDAA** uses scaled down equipment on a proportionally set course. All obstacles will be on a small dog scale. See [www.k9tdaa.com](http://www.k9tdaa.com) for details.

**Show Site:** The show site is indoors on packed dirt. We ask that you exercise the dogs outside and pick up after them.

**Eligibility:** This trial is open to all dogs 17 inches and under at the withers that are over 12 months of age, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

**Mixed breeds are welcome.**

## GAMES CLASSES

Judge's Briefing on the day of the trial supersedes any previous briefing.

**Power and Speed:** Each handler and dog runs a course that is split into two sections: Power and Speed. The Power section of the course consists of technical obstacles, and is not timed. Dogs will earn a 5 second time fault for any mistakes. The Speed section contains a straightforward sequences of jumps only. The goal is for the dog to run the course as fast as possible, preferably with no faults.

**Scoring:** The Speed section of the course is timed. Faults are added to the time.

**Near and Far :** Designed by TDAA judge, Trisha Stall from New York. The purpose of Near and Far is to run the numbered course. At two points on the course there will be "far" sections where the handler must stay behind a containment line while sending the dog ahead to perform the designated obstacles(s).

**Scoring:** Near and Far is scored faults, then time. The lowest score wins with time used as a tiebreaker only. Crossing the containment line is a 10-point fault. Crossing the containment line results in a non-qualifying score as well as the 10-point fault at the Games II and Games III levels.

**Connect the Dots:** The object is to collect points from dot to dot; dots being the contacts. The team will start and finish on the table. No points are required to collect the first dot, but are encouraged. Each obstacle including the dots can only be performed twice for points overall. Each obstacle between dots may be performed only once for points. The dots need to have points in between in order for the dot to count.

**Scoring:** The team has 50 seconds to play. The scoring will stop and all points earned will be safe. Time is only used as a tie breaker.

**Jumpers CDS:** CDS stands for call, direct and send. The team negotiates the numbered course, the course contains three distance challenges that the team may attempt; a call over obstacles, direct to obstacles and a send over obstacles to the finish. All of these challenges are performed with the handler behind a containment line.

**Scoring:** The game is scored time plus faults minus bonuses. The maximum bonus is 30 points.

## STANDARD CLASSES

**BEGINNER AGILITY:** All dogs shall be eligible for participation in this class. There shall be no grandfathering of titles from other organizations.

**INTERMEDIATE AGILITY:** Dogs that have earned the Teacup Beginner Agility Dog (TBAD) or that have satisfied the appropriate Fast Track requirement shall be eligible for participation in this class.

**SUPERIOR AGILITY:** Dogs that have earned the Teacup Intermediate Agility Dog (TIAD) or that have satisfied the appropriate Fast Track requirement shall be eligible for participation in this class.

## GAMES CLASSES

**GAMES I:** All dogs shall be eligible for participation in this class. There shall be no grandfathering of titles from other organizations

**GAMES II:** Only dogs that have earned the Games I (TG1) or that have satisfied the appropriate Fast Track requirement shall be eligible for participation in this class.

**GAMES III:** Only dogs that have earned the Games II (TG2) or Games III (TG3) or that have satisfied the appropriate Fast Track requirement shall be eligible for participation in this class.

### Height Divisions

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division, but not in a division lower than their proper height division.

Dogs that run in a height division lower than their proper division will be eliminated. Provisional dogs must be measured by a judge.

**4" jump height:** For dogs 8" and under at the withers; long backed dogs 12" or less; dogs 12" or less with a 50% or less leg to shoulder ratio.

**8" jump height:** For dogs 12" and under at the withers; long backed dogs 15" or less; dogs 15" or less with a 50% or less leg to shoulder ratio.

**12" jump height:** For dogs 15" and under at the withers; long backed dogs 17" or less; dogs 17" or less with a 50% or less leg to shoulder ratio.

**16" jump height:** For dogs 17" and less at the withers.

### Jump Height Exemptions

"Special provisions are made for dogs that are long-backed; have a weight to height exemption; or who have dwarfish legs. (See rules for complete description of height exemptions)

A jump height exemption (next lower jump height) will also be granted to veteran dogs. (dogs of at least 7 years of age)

## **NEW CLASS**

**FEO:** TDAA now offers FEO (For Exhibition Only) runs. They are open to any TDAA registered dog in any class. These are offered at the option of the local/host club. FEO dogs will run last in the 4" jump height. They may run on lead. FEO runs do not count toward TDAA titles or certificates. No treats or toys are allowed in the ring. FEO teams will receive up to 1.5 times the SCT for their runs.

**Entries close**, at 6:00 PM on February 15, 2010, after which times entries cannot be accepted, cancelled, altered or substituted. Day of Event entries **WILL BE** accepted at an additional fee (See above). Day of Event entries must be given to the Trial Secretary no less than 30 minutes before judging starts. TDAA Registration numbers may be applied for and received at the event so that your dog can participate. Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms. Photocopied entries without the signed TDAA agreement attached are **NOT** acceptable. Unsigned, incomplete or illegible entries are **NOT** acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.

**Returned Checks:** The Trial Secretary will add a \$25.00 service charge for any returned checks.

Subsequent returned checks from the same exhibitor may result in their being put on a **CASH ONLY** basis. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

**Refunds:** No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

**Review your information before submitting the Entry Form.** Incomplete forms will be returned. Please submit one form for each dog entered. If you already have one, include a copy of your TDAA height card for each dog, otherwise your dog will have to be measured.

# Fast Track Move Up

## How the Fast Track Move Up Works

Titles may be grandfathered from other organizations on a “Fast Track” basis.

A dog with a higher title may move up on the same day to the next level of TDAA competition with a qualifying score.

It is possible to move up from Beginners to Superior on the same day if the dog qualifies first in Beginners and then qualifies again in Intermediate.

Likewise, in Games classes, the dogs move from Games I to Games II and then from Games II to Games III.

A qualifying score in the lower class is required to move up to the next level. The dog’s owner must submit a copy of title certificates for the dog.
