AWARDS

Ribbons will be awarded for 1st through 4th in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying score. Fast Track dogs are not eligible for awards in classes through which they Fast-Track. Prizes will be offered for High Point Female and High Point Male. Dogs must be entered in all classes to qualify.

NOTICE TO EXHIBITORS

1. The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and are able to perform all obstacles safely.
2. All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area. It is expressly understood that exhibitors alone are responsible for the actions of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive activity, may, at the discretion of the Trial Committee, be asked to leave the Trial Site.
3. Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
4. Bitches in season are not permitted in the trial. Prior to the show start of the show refunds will be given and no vet statement is necessary. No refunds will be given after the show starts.
5. Exhibitors are responsible for being at the ring gate when it is their turn to run.
6. Exhibitors may wear shirts or insignia of their training group if they wish.
7. At the handler's option, the dog may wear a flat (buckle or quick release) collar without tags or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
8. Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in being excused from the ring.

Obstacle Familiarization— Obstacle familiarization will be held Saturday and Sunday mornings 30 minutes prior to judging for dogs and handlers who have not previously seen TDAA equipment.

Warm—Ups: A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

TDAA uses scaled down equipment on a proportionally set course. All obstacles will be on a small dog scale. See www.k9tdaa.com for details.

Show Site: The show site is indoors on mats. We ask that you exercise the dogs outside and pick up after them.

Eligibility: This trial is open to all dogs 17 inches and under at the withers that are over 12 months of age, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

Mixed breeds are welcome.

GAMES CLASSES

Judge's Briefing on the day of the trial supersedes any previous briefing.

Time Warp: The object of this game is to run the required course as fast as possible without faults. At the challenge point, the handler has the option of staying behind the containment line, and if successfully completed, a 30 second bonus will be deducted from their final time. The teeter or the weaves is the last obstacle. 20 seconds will be deducted from the final time if the weave poles are successfully completed

Scoring: Time plus faults, minus bonus.

Tunnel Crossover: The only obstacles in this game are tunnels and a chute for Games I. For Games II and Games III, there is a set of weaves included. A standard course time will be set, and the object of the game is to get your dog through the obstacles without faults. A 25 second bonus will be deducted from the handlers time, if they direct the dog entirely from the center zone.

Scoring: Time with 25 second bonus subtracted from the final time.

Near and Far: The object is to complete the numbered course. At two places on the course, a containment line will be set where the handler must stay behind it and send their dog. These lines will be adjusted for each level.

Scoring: Faults, then time. Time will be the tiebreaker.

What's My Line: Obstacles will be laid out in a random pattern on the field with no discernible course flow. The object is to perform all the obstacles on the field as quickly as possible without repeating or omitting any. Each obstacle is worth one point.

Scoring: Points, then time.

STANDARD CLASSES

BEGINNER AGILITY: All dogs shall be eligible for participation in this class. There shall be no grandfathering of titles from other organizations.

INTERMEDIATE AGILITY: Dogs that have earned the Teacup Beginner Agility Dog (TBAD) or that have satisfied the appropriate Fast Track requirement shall be eligible for participation in this class.

SUPERIOR AGILITY: Dogs that have earned the Teacup Intermediate Agility Dog (TIAD) or that have satisfied the appropriate Fast Track requirement shall be eligible for participation in this class.

GAMES CLASSES

GAMES I: All dogs shall be eligible for participation in this class. There shall be no grandfathering of titles from other organizations

GAMES II: Only dogs that have earned the Games I (TG1) or that have satisfied the appropriate Fast Track requirement shall be eligible for participation in this class.

GAMES III: Only dogs that have earned the Games II (TG2) or Games III (TG3) or that have satisfied the appropriate Fast Track requirement shall be eligible for participation in this class.

Height Divisions

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in a higher height division, but not in a division lower than their proper height division.

Dogs that run in a height division lower than their proper division will be eliminated. Provisional dogs must be measured by a judge.

4" jump height: For dogs 8" and under at the withers; long backed dogs 12" or less; dogs 12" or less with a 50% or less leg to shoulder ratio.

8" jump height: For dogs 12" and under at the withers; long backed dogs 15" or less; dogs 15" or less with a 50% or less leg to shoulder ratio.

12" jump height: For dogs 15" and under at the withers; long backed dogs 17" or less; dogs 17" or less with a 50% or less leg to shoulder ratio.

16" jump height: For dogs 17" and less at the withers.

Jump Height Exemptions

“Special provisions are made for dogs that are long-backed; have a weight to height exemption; or who have dwarfish legs. (See rules for complete description of height exemptions)

A jump height exemption (next lower jump height) will also be granted to veteran dogs. (dogs of at least 7 years of age)

FEO: TDAA now offers FEO (For Exhibition Only) runs. They are open to any TDAA registered dog in any class. These are offered at the option of the local/host club. FEO dogs will run last in the 4” jump height. They may run on lead. FEO runs do not count toward TDAA titles or certificates. No treats or toys are allowed in the ring.

Disabled Handlers: Disabled handlers will receive an additional 4 seconds in the standard course time for the Standard classes and in qualifying course time for Games classes. Proof of disability shall be a copy of the handler’s disabled parking tag or other official documentation provided with the entry or presented at check-in.

Entries close, at 6:00 PM on February 3, 2012, after which times entries cannot be accepted, cancelled, altered or substituted. Day of Event entries WILL BE accepted at an additional fee (See above). Day of Event entries must be given to the Trial Secretary no less than 30 minutes before judging starts. TDAA Registration numbers may be applied for and received at the event so that your dog can participate. Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry Forms.

Photocopied entries without the signed TDAA agreement attached are NOT acceptable. Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry fee.

Returned Checks: The Trial Secretary will add a \$35.00 service charge for any returned checks.

Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

Refunds: No entry fee will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Review your information before submitting the Entry Form. Incomplete forms will be returned. Please submit one form for each dog entered. If you already have one, include a copy of your TDAA height card for each dog, otherwise your dog will have to be measured.

Fast Track Move Up

How the Fast Track Move Up Works

Titles may be grandfathered from other organizations on a “Fast Track” basis.

A dog with a higher title may move up on the same day to the next level of TDAA competition with a qualifying score.

It is possible to move up from Beginner to Superior on the same day if the dog qualifies first in Beginner and then qualifies again in Intermediate.

Likewise, in Games classes, moving from Games I to Games II and then from Games II to Games III.

A qualifying score in the lower class is required to move up to the next level. The dog’s owner must submit a copy of title certificates for the dog.

The fee must be paid at this trial even if it was paid at an earlier trial.
